Installed On-Site Self-Consumption Solar Power Generation Service at Skylark's Shisui Merchandising Center

Accelerating efforts to achieve virtually zero CO₂ emissions by 2050

Skylark Holdings Co., Ltd. (Headquarters: Musashino, Tokyo; Chairman and CEO: Makoto Tani; TSE Prime Market; Stock code: 3197) has announced that it has introduced and started operation of an on-site, self-consumption solar power generation service (PPA model*) provided by SMFL MIRAI Partners Co., Ltd. (Headquarters: Chiyoda-ku, Tokyo; President: Tatsuro Terada; hereinafter "SMFL MIRAI Partners") which is a strategic subsidiary of Sumitomo Mitsui Finance and Leasing Co., Ltd. (Headquarters: Chiyoda-ku, Tokyo; President: Masaki Tachibana; hereinafter "SMFL"). This is the first time for Skylark Group to introduce the PPA model.

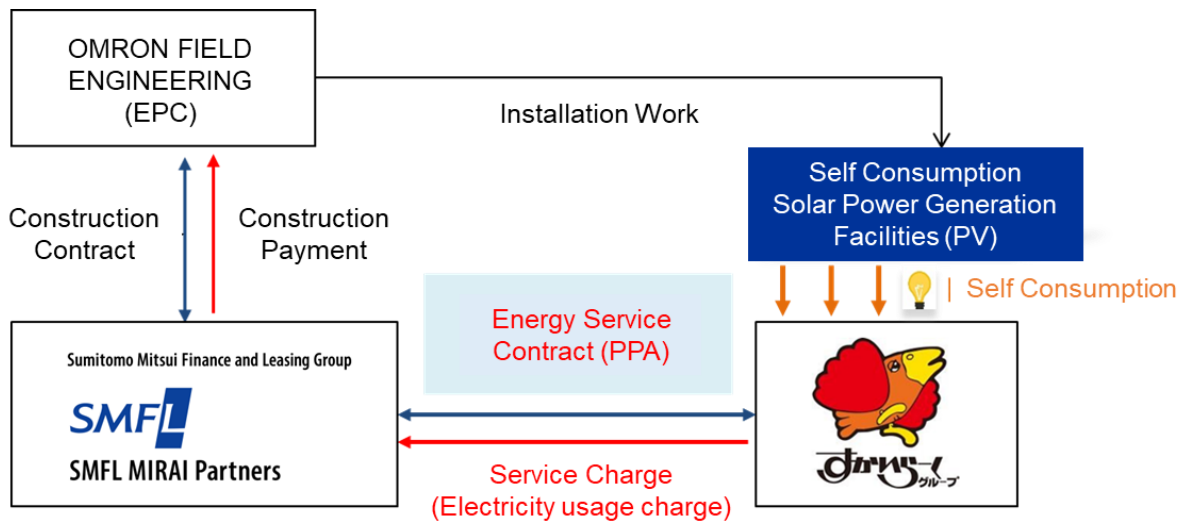


*PPA (Power Purchase Agreement) model: A model where the PPA operator is responsible for setting up a solar power generation system, and electricity generated by the system is purchased from the PPA operator

Toward a Decarbonized Society

The Shisui Merchandising Center is responsible for the primary processing of foodstuffs for approximately 360 restaurants of Skylark Group, and delivers fresh foodstuffs to the restaurants on a daily basis. The installation of a 358kw photovoltaic power generation facility on the site will enable the plant to supply an estimated 458MWh of electricity per year, which is expected to reduce CO2 emissions by approximately 200 tons per year. The entire amount of electricity generated by the facility will be equivalent to 7% of the total electricity used by the Shisui Merchandising Center.

In August 2023, Skylark Group opened an environmentally conscious model store in Higashi-Murayama City, Tokyo, and is accelerating its decarbonization efforts at each of its business locations as well as its stores. Going forward, Skylark Group will continue to work toward sustainable operations throughout the entire supply chain of procurement, manufacturing, logistics, and store operations.
